Hot News - Your Feedback is NEEDED

R12 Track as Asset Flag in Payables logic changed.

In R12 Oracle has changed the logic of checking the Track As Asset flag in AP when an invoice is entered. Oracle use to automatically check this flag when the invoice distribution was hitting an account that was defined in Oracle Assets as an Asset or CIP Clearing Account. Now in R12 AP will no longer validate whether or not the invoice distribution account is an Asset or CIP Clearing Account, it will only validate that the distribution is hitting an Asset Account defined in General Ledger. So in R12 all invoice distributions hitting an Asset Account will now have the Track As Asset flag automatically checked by Oracle regardless if is an Asset or CIP Clearing Account. AP will only identify the distributions hitting an Asset Account Type. The Mass Additions Create program will now validate from the invoice distributions hitting an Asset Account Type which one are Asset or CIP Clearing Accounts and create those lines in the Mass Additions Interface Table. With this change in logic there has been issues and patching required for certain issues, if a line is created by the Mass Additions Create program that is not an Asset or CIP Clearing Account, this line would be identified in Assets as an Expensed Asset Type and will not be able to be capitalized and depreciated.

*** I spoke with Oracle Asset and Payables Development about this change in logic and they understand that this now be confusing to the end used. I would like to get input from the SIG to give back to Oracle Development about this change in logic and if it will be confusing to see the Track As Asset flag checked for all Asset Accounts (Cash, Receivables, etc.).
